**CALLED MEETING**

**Motion #160913-01 Approve Agenda**

It was moved by Mr. McDonald and seconded by Mr. Johnson to approve the agenda as presented.

**Motion #160913-02 Set Tax Rates for 2016**

It was moved by Mr. Mathes and seconded by Mr. McDonald to approve increasing the property and tangible tax revenue rate by 4% which will set the property tax revenue rate at 71.6 cents per 100 dollars. 71.6 cents per 100 dollars includes 0.3 cents increase per 100 dollars allowed by KRS 134.590 due to exonerations losses.
