**Motion #131015-01 Approve Minutes**

### **Motion #131015-05 Approve Addendum to Existing Superintendent's Contract**

Irrespective of any merit-based adjustment in salary during the terms of this Contract, the Superintendent shall receive an increase each school year of this Contract by an amount of at least equal to the greatest percentage increase received by any certified employee on any one rank and step of the district salary schedule. Beginning October 15, 2013, the Superintendent will receive an increase of \$10.19 per pay period through June 30, 2014.
